As you may know, the Plan Administrator is required to file a report annually with the Department of Labor (DOL) known as the "Form 5500 Annual Report" for the Alaska Electrical Pension Plan (Plan). This report contains information about the Plan's financial health as well as demographic information about Plan participants and contributing sponsors. The Plan Administrator filed this report on October 12, 2011, and is required under federal law to provide you with a summary of certain information provided in that report.

The data below supplements – and in some cases, repeats – information you were previously provided on April 29, 2011 in the Plan's Annual Funding Notice for the 2010 Plan Year.

#### Contributions and benefits under the Plan

Contribution rates are determined through collectively bargained contracts (for bargained employees) and special agreements (for nonbargained employees) that vary by agreement and employer.

A participant's benefit accrual is based on a percentage of the contributions required to be made on the participant's behalf by the employer.

The monthly benefit accrual percentage for the 2010 plan year was 1.2% of contributions for covered hours between January 1, 2010 to December 31, 2010.
